That the Council of the Township of Wellesley accept the request under Section 78 of the Drainage Act for improvement to the Campbell Drain 1976 and Bast Drain submitted by Alan and Joyce Wagler for the property described as concession 7 east section part lot 11, east side of Greenwood Hill Road, and further;

That the Council of the Township of Wellesley direct staff to forward the Section 78 request to the Grand River Conservation Authority for comment within thirty (30) days of notice.

Summary:

A Notice of Request for Major Drain Improvement under Section 78 of the Drainage Act was received by the Clerk's Department on August 9, 2024.

Report:

The Notice of Request for Major Drain Improvement is for the Campbell Drain and Bast Drain for the property described as concession 7 east section part lot 11, east side of Greenwood Hill Road. The improvement request, as detailed in the notice, is for constructing a tile drain under the bed of the whole or any part of the drainage works and improving or altering the drainage works if the drainage works is located on more than one property.

Upon Council acceptance of the request, the notice will be forwarded to Grand River Conservation Authority for a thirty (30) day comment period. After the thirty (30) day comment period Council will appoint an Engineer to prepare the Section 78 Report.
