

Drainage By-law Number 29/2024

A by-law to provide for a drainage works in the Township of Wellesley in the Regional Municipality of Waterloo.

Whereas the council of the Township of Wellesley has procured a report under section 4 of the *Drainage Act* for the construction of the Lebold Drain drain;

And whereas the report dated 2024/05/30 has been authored by Curtis MacIntyre, P. Eng. and the attached report forms part of this by-law;

And whereas the estimated total cost of the drainage works is \$410,000.00;

And whereas \$410,000.00 is the amount to be contributed by the Township of Wellesley for the drainage works.

And whereas the council is of the opinion that drainage of the area is desirable;

Therefore the council of the Township of Wellesley pursuant to the *Drainage Act* enacts as follows:

1. AUTHORIZATION

The attached report is adopted and the drainage works is authorized and shall be completed as specified in the report.

2. BORROWING

The Corporation of the Township of Wellesley may borrow on the credit of the Corporation the amount of \$410,000.00 being the amount necessary for the construction of the drainage works.

This project will NOT be debentured.

3. DEBENTURE(S)

The Corporation may arrange for the issue of debenture(s) on its behalf for the amount borrowed less the total amount of:

- (a) grants received under section 85 of the *Drainage Act*;
- (b) monies paid as allowances;
- (c) commuted payments made in respect of lands and roads assessed with the municipality;
- (d) money paid under subsection 61(3) of the *Drainage Act*; and
- (e) money assessed in and payable by another municipality.

4. PAYMENT

Such debenture(s) shall be made payable within _____ years from the date of the debenture(s) and shall bear interest at a rate not higher than 2% more than the municipal lending rates as posted by Infrastructure Ontario on the date of sale of such debenture(s).

(1) A special equal annual rate sufficient to redeem the principal and interest on the debenture(s) shall be levied upon the lands and roads as shown in the schedule and shall be collected in the same manner and at the same as other taxes are collected in each year for _____ years after the passing of this by-law.

(2) For paying the amount _____ being the amount assessed upon the lands and roads belonging to or controlled by the municipality a special rate sufficient to pay the amount assessed plus interest thereon shall be levied upon the whole rateable property in the Township of Wellesley in each year for _____ years after the passing of this by-law to be collected in the same manner and at the same time as other taxes collected.

(3) All assessments of _____ or less are payable in the first year in which the assessments are imposed.
