### Summary:

A Petition for Drainage Works by Owner under Section 4 of the Drainage Act was received by the Clerk on November 5, 2024.

### **Report:**

The Petition for Drainage Works by Owner is for the property described as Part Lot 7, Concession 3 W in the Township of Wellesley. The petitioner's property is within the watershed of another petition currently under review by the Township Drainage Engineer, K. Smart Associates. Under Section 8(4) of the Drainage Act the Council of the initiating municipality may instruct the engineer to make one report with respect to two or more petitions requiring drainage in two or more adjoining areas that require drainage.

Upon Council acceptance of the petition, notice will be forwarded to the petitioners, Grand River Conservation Authority and K. Smart Associates.
